INTRODUCTION

A. Background

Based on Permenpan RB Number 90 of 2021 concerning the Development and Evaluation of Integrity Zones Towards Corruption-Free Areas and Clean and Serving Bureaucratic Areas in Government Agencies, Integrity Zones (ZI) are government agencies whose leaders and staff are committed to realizing Corruption-Free Zones/Clean and Serving Bureaucracy Zones through bureaucratic reform, particularly in terms of realizing clean and accountable governance and excellent public services. Ministries, institutions, and local governments that have been declared as ZI propose one of their work units to become a Corruption-Free Zone.

Corruption-Free Zone (WBK) is a title given to a work unit that has successfully implemented bureaucratic reform, has met most of the criteria for the improvement process in the lever component, and has realized clean and accountable governance and excellent public services. The Clean and Serving Bureaucracy Zone (WBBM) is a title given to a work unit that has successfully implemented bureaucratic reform very well, having met most of the criteria for the improvement process in the lever component to realize clean and accountable governance and excellent public services.

The development of ZI towards WBK-WBBM is a miniature application of bureaucratic reform in several work units that aims to develop a bureaucratic reform program so that it can develop a bureaucratic work culture that is anti-corruption, high-performing, and provides quality public services.

Permenpan RB Number 52 of 2014, as amended by Permenpan RB Number 90 of 2021 concerning the Development and Evaluation of Integrity Zones Towards Corruption-Free Areas and Clean and Serving Bureaucratic Areas in Government Agencies, explains that the process of developing Integrity Zones has several stages that must be passed, namely declaration, development, proposal, assessment, and determination.

The most important stage in the Integrity Zone is the development itself. Development means building integrity in government agency units through various planned, massive, comprehensive, and systematic changes and improvements. Building integrity means building systems, building people, and building culture.

Building systems means developing various instruments, SOPs, and regulations to prevent corruption and other reprehensible acts. Examples include developing a gratification control system, a Whistleblowing System (WISE), an internal control system, and others.

Building people means building a mindset among government officials to be reluctant, ashamed, and feel guilty about committing corruption/other reprehensible acts. The process of building a mindset is not easy, as there will be reluctance and even resistance. In addition, it requires a long time and continuous practice.


The development of Integrity Zones is considered a role model for Bureaucratic Reform in enforcing integrity and quality service. Thus, the development of Integrity Zones is an important aspect in preventing corruption in government.

Integrity Zones is a concept derived from the concept of islands of integrity. Islands of integrity are commonly used by governments and non-governmental organizations (NGOs) to demonstrate their enthusiasm for eradicating and preventing corruption. There are two keywords in the Integrity Zone, namely integrity and island/zone.

Integrity is defined as an attitude or culture that demonstrates consistency between words and deeds and an attitude of rejecting all despicable actions that could harm oneself and one's institution. The zone or island is described as government agency units that have instilled the value of integrity within them.

One of the things that is also emphasized in the Integrity Zone is that it is very possible for new zones/islands to emerge that also implement the integrity system within them. The emergence of these new islands is made possible through a process of replication by other government agency units to government agency units that have already instilled the integrity system.
